Dear Parents

Year 4 will be taking the next step in their exploration of the many interesting myths and legends that can be heard and read about, in and around Cornwall. This follows on from 'The Legend of Zennor' that we investigated in Year 2, and also links to classroom learning about mountains and rock formations.

The main activity of the day will be to use maps and photographic clues to find out how much truth there may be in the legendary story of the feud between the Cornish giants 'Bolster' and 'John of Gaunt' - which legend tells us culminated in the formation of the fascinating rock structures that can be seen today on Carn Brea hill top.

On Wednesday 3rd April/Thursday 4th April your child is invited to participate in this outdoor learning experience led by Mr.Spriggs and accompanied by a classroom teaching assistant. We will be using the school minibus for this trip and will be leaving promptly at 8:55 am. We will begin our return journey with ample time to arrive back at school before the end of the school day. However, if we are delayed due to traffic, a text message will be sent notifying you of this. Please complete the consent form attached (or the online consent assessible via ParentPay) and return it to school by **Friday 29th March** if you are willing for your child to attend this trip.

Your child will need a packed lunch as well as a drink (no fizzy drinks please). The school can provide packed lunches should you wish to pre-order a meal. We will provide a lunch for pupils who are entitled to free school meals. Please order packed lunches via the school office before **Wednesday 27th March**. A bag suitable for carrying the packed lunch will be needed, as we will be having a picnic lunch away from the minibus if the weather is good.

Your child will need clothes suitable for taking part in outdoor tasks, in any weather (a coat must be taken). I would suggest that your child also brings a hat and gloves. Damp feet from wet pathways and puddles may be a possibility if it has rained recently, so wearing wellies would be a good idea. If we have had dry weather, then comfortable trainers would be suitable.
