Phonics and Reading

Each week spellings are sent home for children to learn before their spelling test. We have now started to send spellings home from their phonics group that link directly to the sounds being learnt. This means that the spellings set may be by another adult and not the class teacher. Please ensure that you are helping your child to learn these.

Reading is an essential life skill and underpins everything that we are doing in school. We expect children to read at home and have their reading records written in at least 5 times per week. Each week we are going to collate how often children are reading from each class and award a class of the week accordingly.

Mobile Phone Policy

We request that parents do not use mobile phones in the school building or grounds.

Should phone calls and/or texts need to be taken or made, use is restricted to those areas not accessed by children or **outside the school grounds** in order to avoid any unnecessary disturbance or disruption to others.

Mobile phones must never be used to take photographs of children in the school building or grounds.

Any breach of these procedures could lead to the headteacher and governing body being informed and consequently disciplinary action according to the schools procedures.

We very much appreciate our parents' support in implementing this policy in order to keep your children/our pupils safe.

Inhalers

The regulations governing the use of emergency inhalers in schools have changed. We are now able to hold an inhaler in school for emergency use eg if an inhaler is empty or broken. <u>This does not replace the</u> requirement for parents to provide medication for their child.

This means that we no longer require parents to provide spare inhalers to be kept in school. We are required to get written consent for a child to use an emergency inhaler and letters will be sent to parents next week with more information.

If you have provided a spare inhaler for your child we will replace inhalers in the classroom as they run out with the spare. However if you would like to have your spare inhaler returned please see Mrs Rowe or Mrs Tippett

Is Your Child Eligible for Free School Meals?

Cornwall Council believes that when children eat better, they achieve better. Whether families are paying for school meals or are entitled to them for free, children are more likely to concentrate in the classroom in the afternoon



Are you entitled?

after eating healthy school lunches in a pleasant environment. This also improves their health and their learning about making better food choices. Your child may be eligible for free school meals if you

(or the child themselves in their own right) is in receipt of any of the following benefits.

- Income Support (IS)
- Job Seekers' Allowance (Income-Based) and equal based Job Seekers Allowance.
- Income Related Employment and Support Allowance (ESA-IR) and equal based Employment and Support Allowance.
- Child Tax Credit (CTC) with an Annual income of less than £16,190.
- Guarantee Element of Pension Credit (GPC)
- Immigration and Asylum Act 1999 (IAA) Support
 Universal Credit

Please note that anyone claiming Working Tax Credit, Contribution-Based Job Seeker's Allowance and/or Contribution-Based Employment and Support Allowance is NOT eligible for free school meals, regardless of what other benefits/credits are being claimed. However, you will be temporarily eligible to claim free school meals if you receive a Working Tax Credit run-on, which is the payment someone may receive for a further four weeks after they stop qualifying for Working Tax Credit. Since 1 September 2014, all Key Stage 1 (Reception, Year 1 and Year 2) pupils have been entitled to receive a free school meal as part of the Universal Infant Free School Meals (UIFSM) initiative, regardless of what benefits are being claimed. However, if you are in receipt of the benefits listed above which would entitle your child to free school meals anyway, your school may be entitled to claim
